ORDER

WHEREAS, Raghu Saroj Welfare and Charitable Trust, Plot No. 488/1429, Street No.- Thana Road. Vill.- Ambedkar Nagar, PO.-Jehanabad, Town/City-Jehanabad, Tehsil/Taluka- Jehanabad, Dist.-Jehanabad, Bihar-804408 (Code No.ERCAPP167) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC Order No.12270 dated 30.06.2012, followed by revised order vide No.32287 dated 27.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 270th Meeting held on 25th – 26th March, 2019 considered the matter in its meetings held time to time along with the reply dated 05.03.2019 submitted by the institution in response to Show Cause Notice and observed as under:

- (i) Show Cause Notice u/s 17(1) was issued on 14.02.2019.
- (ii) The submitted building completion certificate is not in the NCTE prescribed proforma and not signed by Govt. Engineer.
- (iii) The submitted photocopy FDRs Rs.5 lakh and Rs.3 lakh is partially handwritten and partially typed and no bank letter showing joint mode submitted.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No.ERCAPP167 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

3. **AND WHEREAS**, the order of withdrawal was not issued to the institution and the matter was re-considered by ERC in its 271st meeting held on 24-25 April, 2019 under the Agenda Item No.271.1.7 before confirmation of proceedings of 270th ERC meeting held on 25-26 March, 2019.

4. **AND WHEREAS**, the ERC in its 271st meeting held on 24-25 April, 2019 analyzed the representation vide Ref. No.RSWCT-37/2019 dated 11.04.2019 along with enclosures submitted by the institution on the basis of decision taken in 270th meeting uploaded on ERC website and decided as under:




